Please note that payment deadlines for the 2027 InterNationals are earlier than in previous years.

- **Registration, Initial Deposit, and Registration Materials Due:** December 1, 2026

- **Final Payment Due (including all Friends & Family reservations):** December 31, 2026
- **Any Paid or At-Large InBid can be applied until the competition dates.**



As Friends & Family members are added to your reservation, your outstanding balance will be adjusted accordingly.

Accepted Forms of Payment

Payment will be accepted: Certified Check, Money Order, School Purchase Order, VISA, MasterCard, American Express, or Discover.

Checks should be made payable to **AmeriCheer** or **AmeriDance**. Please do not send cash.

A **\$50 returned check fee** will be assessed for any check returned. All credit card transactions are subject to a **3% processing fee**.

Resort Accommodations

The official resort options for the 2027 InterNationals include:

Resort accommodations cannot be guaranteed until payment is received in full. Resort reservations are available on a first-come, first-served basis, and inventory at each property is limited.

To help ensure your entire group is accommodated together, we strongly encourage athletes, coaches, friends, and family members to book at the same time. Due to the limited availability of resort packages, reservations should be made as early as possible.

Resort & Registration Changes

All registration, rooming, and resort package changes must be submitted by January 15, 2027.

For late and significant registration changes received after January 1, 2027, a \$100 Express Registration Fee will be assessed.

To ensure accurate event planning and resort accommodations, **no changes will be accepted after February 1, 2027.**

Refunds & Cancellations

To receive a full refund (excluding the deposit), cancellation must be received in writing by December 31, 2026.

Cancellation Schedule

- **January 1–15, 2027:** 50% of fees paid (excluding deposit) will be refunded following the event.
- **January 16, 2027 and after:** No refunds will be issued.

All cancellation and refund requests must be submitted in writing to your Registration Manager and emailed to events@americheer.com. A confirmation of cancellation will be provided by a member of the AmeriCheer Family of Brands team.

Refund requests will not be approved unless a written request is received prior to the applicable deadline. Cancellations submitted by phone only will not be accepted.

In the event that AmeriCheer/AmeriDance is forced to cancel the event due to circumstances beyond its reasonable control (force majeure), a refund of up to 50% of fees paid, excluding deposits, may be granted. Event transfers and event/camp credits may also be offered as alternative options.

Please note that all approved refunds resulting from cancellations will be processed approximately **6–8 weeks following the conclusion of the event**.
